# 3.3 Adoption - By-law #202 - Circulation of heavy vehicles on Beaven Lake road and White's road

WHEREAS that paragraph 5 of section 626 of the Highway Safety Code (RSQ, c. C-24.2) allows the municipality to pass a by-law to prohibit all vehicular traffic on the roads it indicates provided that the prohibition is indicated by appropriate signage;

**WHEREAS** Article 291 of the Highway Safety Code (RSQ, c. C-24.2) allows the municipality to restrict or prohibit on a road, which is responsible for the maintenance, the movement of all or certain heavy vehicles;

**WHEREAS** Article 291.1 of the Highway Safety Code (RSQ, c. C-24.2) provides that the restriction or ban on driving provided for in Article 291 may be partially lifted, with appropriate signage, to allow to get to a place where you can access entering the prohibited zone in order to take or to deliver goods, to provide a service, to execute a job, to have the vehicle repaired or bring it to its base;

**WHEREAS** it is necessary to regulate truck traffic on public roads whose maintenance is the responsibility of the municipality to ensure the protection of the road network, citizen security and tranquility of the residential areas;

**WHEREAS** the council wishes to regulate the movement of heavy vehicles on White and Beaven lake roads;

**WHEREAS** White's road is an inter municipal road shared by the Municipality of the Township of Harrington and the Municipality of the Township of Arundel;

**WHEREAS** the Municipality of the Township of Harrington was consulted and confirmed its support of said by-law by giving a notice of

motion at the council meeting held July 6th, 2015 announcing their intention to regulate the movement of heavy trucks on White and Beaven Lake roads on the sections under their management;

WHEREAS the Municipality of Montcalm was consulted and confirmed its support of said by-law by giving a notice of motion at the council meeting held July 13th, 2015 announcing their intention to regulate the movement of heavy trucks on Beaven Lake road on the section under their management;

WHEREAS a Notice of Motion of this by-law was given at a council meeting held July 17th, 2015;

# **5.1 Mandate airborne LiDAR survey system - 3D Mosaic Group Géniearp**

**WHEREAS** the Municipality of Arundel adopted in August 2013 bylaw #174 concerning the establishment of a local fund reserved for the repairs and maintenance of certain public roads;

WHEREAS to meet the needs of the fund, a fee is payable by each operator of a quarry or sand pit, located on the territory of the municipality and whose operation is likely to result in transit through municipal public roads of substances specified in the second paragraph;

**WHEREAS** the fee payable by an operator is calculated based on the amount, expressed in metric tons or cubic meters, processed or not, substances that pass from its site and are surface mineral substances defined in Section 1 of the Mining Act (RSQ, chapter M-13.1) or substances from the recycling of demolition debris of buildings, bridges, roads or other structures;

**WHEREAS** that an operator of a site of a quarry or sand pit located on the territory of the municipality must file a return, as provided by the by-law #174;

**WHEREAS** the municipality can judge the accuracy of a statement described under by-law #174 by taking an aerial photo of the quarry site or quarry and its analysis by a calculation method which allows to assess the quantity of substances extracted and an inspection of the quarry site or quarry by an officer or employee or agent of the municipality;

**WHEREAS** that the Group Géniearp 3D Mosaic filed an offer of services for the production of an airborne survey by LiDAR control system with GPS in order to create a digital terrain model in 3D setting the day of the survey, the exact topography (+ / - 7cm) in height difference of each of the quarry sites and quarries and thus provide a 3D image for each geo-referenced survey, subsequently, serving as the basis for volumetric calculations;

### CONSEQUENTLY,

It is moved by councillor Joanna Nash

And carried:

**THAT** council mandates the Géniearp 3D Mosaic Group to produce an airborne LiDAR system with GPS control, all according to the offer of services received August 5th, 2015 in the amount of 5 461.31 \$ including taxes;

**THAT** the amount of this expense be paid from local funds for the repair and maintenance of certain public roads.

5.2 Grant Application - Rehabilitation of the local network - Acceleration of investment in the local road network (AIRRL) - Lake Beaven Road

**WHEREAS** the Ministry of Transport (MTQ) filed a new financial assistance program for the rehabilitation of the local network in order to accelerate investment in the local network (AIRRL);

**WHEREAS** that this component allows for the payment of subsidies exclusively to finance the completion of work on local road infrastructure such as improvement of the road and other road components;

**WHEREAS** the AIRRL component is used to finance work on local roads of levels 1 and 2, recognized by the MTQ, excluding the portion designated priority, within a local road infrastructure intervention plan for PIIRL for municipalities with less than 100,000 inhabitants;

**WHEREAS** Lake Beaven road is ranked at level 2 by the MTQ and the planned work is eligible for this grant program;

**WHEREAS** the municipality has identified Beaven Lake Road as a project to achieve in the short term in its 2015-2017 triennial plan and states that it is very urgent to carry out remedial work given the state of advanced deterioration of one section of the road;

WHEREAS that the Municipality conducted a study and got recommendations for a problematic sector of Beaven Lake road for approximately one hundred linear meters in August 2013 (100 lin.m.);

WHEREAS that such work will generate costs of about 121 000 \$;

### CONSEQUENTLY,

It is moved by councillor Hervey William Howe

And carried:

**THAT** council request to the Ministry of Transport of Quebec, financial assistance under the road rehabilitation program – under the section investment acceleration of the local network, for work on Beaven Lake road, given its very advanced state of deterioration on a section of the road;

**THAT** the council confirms that it is a priority for the municipality for work to be performed at that location;

**THAT** said project meets the eligibility criteria specified in the rehabilitation of the local network program – section investment acceleration;

**THAT** the Municipality approves the application and commits to completing the work within a period of twelve (12) months from the issuance of the letter announcing the grant from the Minister.

WHEREAS the municipality conducted a study and got recommendations for a problematic sector of Beaven Lake Road for approximately one hundred linear meters in August 2013 (100 lin.m.);

**WHEREAS** that since receiving that study, the state of Beaven Lake Road continued to deteriorate and that corrective work must be done in the next year;

WHEREAS the offer of services received from Équipe Laurence;

### CONSEQUENTLY,

It is moved by councillor Bernard Bazinet

And carried that the firm Équipe Laurence be mandated to prepare plans and specifications and to carry out technical monitoring for remedial work on the Beaven Lake Road, over a length of about one hundred (100) linear meters for a total of 6100\$ plus applicable taxes.

# 7.1 Request for bids 07-2015 - Installation of a synthetic grass coating at Beaven Creek Park

**WHEREAS** the municipality on July 22<sup>nd</sup> 2015, launched a tender for the installation of a synthetic turf coating on the electronic tendering system of the Government of Quebec (SÉAO);

WHEREAS the municipality has received three (3) bids;

**WHEREAS** by tender, the lowest bidder Tapico Quebec Inc. has not submitted a product that meets the required specifications and specifically has not submitted a product that meets the specifications required by Article 2.1 of the specifications of the particular technical clauses;

**WHEREAS** that it is, in the opinion of the municipality, major irregularities that will entail automatic rejection of the bid from Tapico Quebec Inc.

**WHEREAS** the bidder representative of Tapico Québec Inc appears not to have been sworn in, which also leads to automatic rejection of the bid;

WHEREAS that, should the court come to the conclusion that these irregularities were only minor irregularities, the town council cannot consent to correct these irregularities and for all these reasons rejected the bid from Tapico Quebec Inc;

WHEREAS by its bid of the second lowest bidder Pro-Turf Synthetic Grass Inc. has not submitted a product that meets the required specifications and has major irregularities, such as the absence of the consent letter of guarantee (100% / 100 %), valid for 90 days and the resolution authorizing the signatory of the tenderer of the bid;

**WHEREAS** it is, in the opinion of the municipality, major irregularities that will entail automatic disqualification of the bid of Pro-Turf Synthetic Grass Inc;

**WHEREAS** should the court conclude that these irregularities were only minor irregularities, the town council cannot consent to correct these irregularities and for all these reasons rejects the bid of Pro- Grass Synthetic Turf Inc;

**WHEREAS** that the representatives of these two (2) bidders acknowledged verbally that they have not submitted a product that meets the specifications required by Article 2.1 of the specifications of the particular technical clauses;

**WHEREAS** the third bidder, Les Surfaces sécuritaires Carpell Inc. produced a compliant bid but exceeded excessively and substantially the estimated and budgeted amount for this project;

WHEREAS the Municipality of Arundel has several other priority projects to be completed and lacks the financial capacity to pay more

than the maximum cost foreseen for the project to install a coating of synthetic grass and therefore the Town council cannot award the contract to the latter company and is obliged to reject all tenders received for this call for tenders 07-2015;

**WHEREAS** the Municipality has not committed itself to accept the lowest or any tender, and without obligation of any kind to bidders;

# CONSEQUENTLY,

It is moved by councillor Daniel L. Fournier

And carried:

**THAT** the preamble is an integral part hereof;

**THAT** council rejects all bids received under 07-2015 bidding on SÉAO for the installation of a synthetic grass coating.
