	WHEREAS that in order to help finance its legal and representation costs, the Municipalité de Ristigouche Partie Sud -Est has launched the "Solidarité Ristigouche" campaign with the goal of raising \$225,000 and thanks to the generosity and solidarity of citizens across the country and municipalities, over \$182,000 was raised, 80% of their goal;
	WHEREAS that the leaders and lawyers of Gastem are making the trial more complex and lengthier, thereby raising the costs of defense;
	WHEREAS that the Municipalité de Ristigouche Partie Sud-Est does

not have the financial capacity to face this lawsuit since the population of this municipality counts 157 citizens and that their budget of annual collection of municipal taxes totals \$134,000 per year;

WHEREAS that the Municipalité de Ristigouche Partie Sud-Est must increase its funding target, with the goal of raising \$328,000;

WHEREAS that the "Ristigouche" file concerns all the municipalities in Québec and that the issue is now legalized;

WHEREAS that the Fédération québécoise des Municipalités, the Union des Municipalités du Québec and several municipalities have shown great solidarity in contributing to their fundraising campaign;

WHEREAS that the Municipality of Arundel understands the stakes of this file and wishes to support this campaign of financing taking into account its limited budget considering that it is itself a small municipality of 589 citizens;

And carried to grant a financial assistance of \$200 to the Municipalité de Ristigouche Partie Sud-Est to support it in its fundraising, as part of its campaign "Solidarité Ristigouche".
