4.1 Compensation for use of cellphones - Head of First Responders

WHEREAS the head of the first responders is using his personal cell phone to receive emergency calls and must conduct the administrative management of the service;

4.2 Agreement on protection against fire and providing for the establishment of an intermunicipal management

WHEREAS the Municipality of Arundel in reliance of section 468 and following of the Law of Cities and Towns and section 569 and following of the Municipal Code to conclude an agreement for the establishment of a fire safety service for the whole territory of the municipalities of Amherst, Arundel, Huberdeau, Lac Supérieur, La Conception, La Minerve, Montcalm and Saint-Faustin-Lac-Carré;
