	WHEREAS that this request for a minor variance has been made in the context of a project to build an industrial garage;
	WHEREAS that the use class "Medium Industry", within which construction companies are included, is currently authorized to the zoning by-law for the Ru-23 zone where the property is located;
	WHEREAS that the request for a minor variance is intended to:
	- authorize the construction of a carport to store machinery in the front yard while these are only permitted in the side yards and backyards;
	- authorize the construction of two (2) carports to store machinery with three (3) sides closed while the maximum of closed sides is two (2) for this type of construction;
	WHEREAS that the proposed development will further preserve the recreational and residential character of the area compared to a traditional implantation with a façade on the road that would require complete deforestation in the front yard;
	WHEREAS the height of the projected garage will be thirty-two (32) feet, that the projected exterior covering will be in wood-style board and batten green and/or beige and that the coating of the projected roof will be black or brown asphalt shingles, thus limiting the visual impact of the building in the area;
	WHEREAS that the negative effects on the neighborhood will be less with the proposed development;
	WHEREAS that the Mayor has invited the assistance to make their comments or their opposition with respect to this request for a minor variance;
	WHEREAS that no comments or objections have been filed with respect to this application for a minor variance;
	WHEREAS the recommendation of the Planning Advisory Committee to accept this request;

And carried that council approves this request for a minor variance and authorize the construction of a carport to store machinery in the front yard while these are only permitted in the side yards and backyard as well as the construction of two (2) carports to store machinery having three (3) sides closed, while the maximum of closed sides is two (2) for this type of construction, for the property located at 30 Golf road, roll number1894-22-0916 under the following conditions:

- That only one vehicular access with a maximum width of twenty (20) feet be set up for this new usage and that conifers with a minimum height of 1.5 meters be planted, if required, to reduce the size of the existing access to the site, with the species of trees chosen to reach a minimum height of six (6) meters at maturity;

- That a wooded strip in the natural state (without human intervention) of a minimum width of eight (8) meters, on the whole of the front line, with the exception of vehicular access, be kept at all time and that any diseased, damaged or dead trees in this band be replaced by a conifer with a minimum height of 1.5 meters when planting, with the tree species chosen to reach a minimum height of six (6) meters at maturity;

- That none of the existing trees located at the boundary of lots 16-16 and 16–17 be cut and that any sick, damaged or dead trees in this band be replaced by a conifer with a minimum height of 1.5 meters during planting, the chosen tree having to reach a minimum height of six (6) meters at maturity;

- That a site plan and an installation of the proposed building including the identification of the front wood lot on the site be prepared by a land surveyor prior to the issuance of the building permit. The plan must indicate, in addition to the usual elements, the distance of the planned commercial building from the neighboring residences.
