3.1 Request for a minor variance – Doctor Henry road – roll number 1792-34-7199

WHEREAS: The objective of the proposed cadastral operation is the creation of two (2) lots with a minimum frontage (minimum required width) is not consistent in the front of Doctor Henry road. Indeed, the minimum frontage of 60 meters is required and the proposed frontage is 47 meters;

WHEREAS: The current frontage of the site to be subdivided is 94 meters and the owner has the ability to build a road that would create lots in conformity;

WHEREAS: That the creation of two lots on Doctor Henry Road at this point, could result in the construction of two new driveways, which would reduce safety on this stretch of road;

WHEREAS: The lot being subdivided includes an area at risk of soil movement and that it was clearly identified on the preliminary plan 22561prepared by the surveyor John Simon;

WHEREAS: The construction of a home, the implementation of a water treatment system for waste water and a single well could be created on each of the lots, and, taking into account of the danger of soil movement ;
