WHEREAS the will of the municipality and the Red Cross to agree to an agreement;

WHEREAS that the agreement for disaster services between the municipality and the Canadian Red Cross must be renewed;

WHEREAS that the municipality wishes to avail itself of the services of the Red Cross during minor or major disasters;
