WHEREAS the company 9181-9102 Québec inc. is presenting to the Commission de protection du territoire agricole du Quebec (CPTAQ) a request for authorization for the relocation of an area of 5 000 square meters for a residential purpose on lots 12-P and 15-5-P of Range 8, cadastral register of the Township of Arundel;

WHEREAS that the land in question is located in an agricultural zone and that in such cases the *Act respecting the preservation of agricultural land and agricultural activities* (RSQ, c. P-41.1) requires that any request for relocation of an area of 5 000 square meters for residential use is subject to authorization by the CPTAQ;

WHEREAS the request does not violate any provision of the urban planning by-laws of the Municipality;

WHEREAS the Municipality has already approved in August 2010 by its resolution 2010-1205 a request to use for a purpose other than agriculture for the same lots;

WHEREAS that the new application is primarily intended to move the location of the area of 5 000 square meters for residential purposes authorized by the CPTAQ's decision # 369481 dated January 25th 2011;

8.1 Support - Canada-Wide campaign for the neutral and standardized packaging of tobacco products

WHEREAS that smoking is the most important cause of disease and death in Canada, killing 37,000 people each year;

WHEREAS that the tobacco epidemic is caused by an industry that puts profits before people's lives and using all means at its disposal to make its products more attractive with a less dangerous appearance;

WHEREAS that the packaging is one of the most powerful promotional vehicle for tobacco products;

WHEREAS the Federal Tobacco Control Strategy 2012-2017 must be renewed by March 2017 and that the standardization of packaging should be one of the first measures implemented as part of this improved strategy that will target aggressive goals for a reduction of smoking;

WHEREAS pursuant to the recommendation of the World Health Organization, Australia, France, the United Kingdom and Ireland have all adopted laws requiring neutral and standardized packaging of tobacco products, and many other governments have announced plans to do so soon;

CONSEQUENTLY,

It is moved by councillor Marlene Séguin

And carried that the Municipality of Township of Arundel supports that Canada requires neutral and standardized packaging of tobacco products as described as follows:

The neutral and standardized packaging would prohibit all promotional items of all tobacco packages, including the use of colors, images, logos, slogans, distinctive fonts and finishes. Only the brand name would be allowed there and for whom will also be subject to restrictions. Nominations for health care remain present on the packaging. The size and shape of the packaging are standardized, thus prohibiting specific formats such as packets of cigarettes thin and ultrathin, which reduce the size of the warnings and openly targeting women. The appearance of cigarettes would also be standardized, for amongst other things, prohibit the use of brand images, logos, colors and special finishes, and set standards on the length and diameter of the cigarettes.
