9.3 Support - Problematic of transporting wood from public forests via municipal roads

WHEREAS the municipalities invest significant amounts each year in maintenance, repairs and overhaul of municipal roads;

WHEREAS the problem of financing the maintenance of municipal roads used to transport wood from the large public forest is a major problem for the municipality and for the entire region;

WHEREAS municipal roads were not, for most of them, designed for the heavy transport of heavy goods vehicles, which causes significant and costly damage to the running surface and the foundation of the said roads:

WHEREAS no municipality in the MRC des Laurentides receives royalties when the transportation exceeds 1000 trips per year;

WHEREAS since the said royalty paid by the MTQ is non-existent and the municipalities must tax their citizens to defray the costs necessary to maintain their roads;

WHEREAS the municipalities of the MRC des Laurentides have a high rate of vacationers near the territories targeted by logging, the uses of which lead to significant social and problematic incompatibilities related to safety;

WHEREAS that the flow of water and the flow of watercourses can be altered by the presence of multiple forestry activities and cause significant negative impacts on municipal roads, because they intercept the water during precipitation, which affects natural drainage zone due to erosion and sedimentation:

WHEREAS that, as a result of forestry operations, the perceptible problems of erosions and sedimentation conveyed affect the ecological integrity of the water bodies and undermine the efforts of the municipalities as well as those of the lake associations against the fight of invasive species;

WHEREAS municipalities are worried about the risk of accidents for its citizens and users by the increase in heavy truck traffic where lane sharing is unsuitable on narrow roads;

WHEREAS the council of mayors of the MRC des Laurentides by resolution 2017-04-7127 supports the Municipality of La Conception in its request to the Ministry of Transport, Sustainable Mobility and Transport Electrification for the recognition of the dual vocation of certain roads;

WHEREAS the municipalities concerned have prohibited the

movement of heavy vehicles on municipally regulated roads;

WHEREAS in a communication dated June 1st, 2017, the Ministry of Transport, Sustainable Mobility and Transport Electrification rejects the principle of "double vocation" roads and recognizes that heavy transport is prohibited in the territory of some municipalities;

CONSEQUENTLY,

It is moved by councillor Marc Poirier

And carried:

THAT the Municipality of Arundel support the municipalities of the MRC des Laurentides in their dealings with the Ministry of Transport, Sustainable Mobility and Transport Electrification in the issue of transporting wood from the public forest via municipal roads;

THAT the Ministry of Forests, Wildlife and Parks develop a plan for access to the forest resource throughout the territory so that it can harmonize within the framework of the new planning scheme of the MRC des Laurentides;

THAT the Ministry of Forests, Wildlife and Parks, the Ministry of Transport, Sustainable Mobility and Transport Electrification as well as the industries work to find possible solutions to extract the resource from the public forest directly on provincial roads;

TO request the support of the surrounding municipalities, the MRC des Laurentides, the Fédération québécoise des municipalités and the Union des Municipalités du Québec;

TO further convey this resolution to the following Ministers and Members:

- Christine St-Pierre, Minister responsible for the Laurentian region;
- Martin Coiteux, Minister of Municipal Affairs and Land Occupancy;
- André Fortin, Minister of Transport, Sustainable Mobility and Transport Electrification;
- Sylvain Pagé, MPP for Labelle;
- David Graham, Member of Parliament for Laurentides-Labelle County
