6. 9-1-1 call center - Delegation to the MRC des Laurentides

WHEREAS the MRC are responsible for the risk coverage schemes on their territory;

WHEREAS the need expressed by the fire departments on the territory of the MRC des Laurentides;

WHEREAS the agreements for all of the cities and municipalities served by the Mont-Tremblant 9-1-1 center have expired since March 1st, 2020;

WHEREAS an agreement for primary and secondary 9-1-1 calls can be signed by an MRC in order to ensure that all of the cities are served by the same call center to ensure better cohesion and respect the fire risk cover scheme;

WHEREAS the objective is to ensure complete and uniform coverage in the territory including all civil security partners;

WHEREAS the objective of finding an effective and efficient service at a lower cost;

WHEREAS the MRC can be served at no additional cost by a call center other than the current one;

WHEREAS the steps taken jointly by the five fire departments of the territory in the fall of 2019 to find a supplier that meets these requirements;

WHEREAS three (3) suppliers have been considered and met;

WHEREAS the offer presented to the MRC des Laurentides of the Central emergency calls Chaudière-Appalaches (CAUCA), a non-profit organization, meets these objectives;

WHEREAS the current supplier, the City of Mont-Tremblant, will provide the service until the transfer to the new supplier is effective;

CONSEQUENTLY,

It is moved by councillor Paul Pepin

And carried that the Municipality of Arundel delegate its responsibility for the 9-1-1 call center to the MRC des Laurentides.
