WHEREAS the municipality wishes in the meantime to ensure the maintenance of this road not only in winter as it is already doing, but in all seasons, given the state of neglect of this road caused by the lack of clarity regarding its true status, and the impact on the image of the municipality and its local development, given that it leads to a site and an activity of great heritage value to the municipality of Arundel, the Arundel Golf Course, which has existed for nearly 75 years.

WHEREAS the Ville de Mont-Tremblant is authorized, by virtue of its certificate of authorization no. 4820-15-01-02434-16 (401917120), issued by the Ministère de l'Environnement et de la Lutte contre les changements climatiques (MELCC), dated April 21, 2022, to carry out, during the years 2020 to 2022, biological control of biting insects by means of aerial and terrestrial application of B. t. i. (Bacillus thuringiensis) bio-pesticides (Bacillus thuringiensis Berliner var. israelensis, serotype H-14) or Bacillus sphaericus (the Bio-pesticides);

WHEREAS under the terms of this certificate of authorization, the City of Mont-Tremblant is not only authorized to carry out these spraying operations on its territory, but also on that of the Municipality of Arundel, while the municipality has at no time given its consent to such spraying, nor participated in a request to this effect to the Ministry

WHEREAS it is in the interest of the Municipality of Arundel and its citizens to inform the MELCC as well as the Ville de Mont-Tremblant and its subcontractors in charge of the spraying, of the refusal of the Municipality of Arundel to allow any aerial or terrestrial spraying of B. t. i. (*Bacillus thuringiensis Berliner var. israelensis, serotype H-14*) or *Bacillus sphaericus* (the "Bio-pesticides"), or otherwise, within the Municipality of Arundel for 2022 and thereafter until such time as the Municipality of Arundel provides its prior consent.

WHEREAS the municipality wishes to respond to the particular needs of its many seniors in accordance with orientation 3 entitled "Wellness, health and safety" of the 2022 Council's major orientations, resolution 2022-0008, as well as the objectives of the 2021-2025 municipal family policy

WHEREAS the needs of the municipality's seniors in terms of transportation, particularly for medical appointments that are often located at significant distances and that require vehicles and often a driver for both the journey to and from the hospital

WHEREAS it is opportune to facilitate access to transportation services for its seniors by setting up an assistance program, free of charge or at low cost, for this purpose, in partnership with the Centre d'action bénévole des Laurentides (CABL) **WHEREAS** the municipality wishes at the same time to encourage local volunteerism with the Centre d'action bénévole des Laurentides (CABL) to make this service even more effective.

ESTABLISH a program of assistance to accompany-transport residents of Arundel aged 65 years and over to their medical appointments, in effect until December 31, 2022.

TRANSPORTATION TO MEDICAL APPOINTMENTS FOR PERSONS 65 YEARS OF AGE AND OLDER

The Municipality of the Township of Arundel (Municipality) offers a transportation assistance program for residents of Arundel 65 years of age and older to attend medical appointments, in accordance with the service agreement established between the Municipality and the Centre d'action bénévole des Laurentides (CABL).

Under this municipal program, CABL provides the volunteer transportation service according to the terms and conditions of reservation and transportation below, while the Municipality administers and covers the costs partly or entirely for this service as follows:

A. Cost of transportation to and from each medical appointment, paid in whole or in part by the Municipality of Arundel:

- 1. Less than 200 km round trip: e.g.: Mont-Tremblant, Sainte-Agathe, Rivière-Rouge, Hawksbury, Saint-Jérôme: free
- 2. More than 200 km round trip (maximum 400 km): e.g.: Montreal: 50% of the amount paid by the municipality (\$0.58/km*)

*This amount could be revised during the program.

<u>B.</u> Pre-registration to the program and conditions before the appointment with the Municipality of Arundel:

- 1) Any eligible person wishing to benefit from this program must:
 - a) Register for the program with the municipality beforehand (fill out the form) and;
 - b) Provide identification and proof of residence.
- 2) During the course of the program, in order to benefit from this program, any eligible person will have to :
 - a) Provide proof of medical appointment, upon request;
 - b) For appointments over 200 km (option A.2), prior to booking, provide a deposit (at least 25%) and proof of medical appointment and pay the balance within 30 days of billing.
- 3) The municipality reserves the right to refuse any request for accompaniment-transportation in the event of non-payment of a previous unpaid balance within the time limit.

C. CABL Reservation and Transportation Terms and Conditions:

- 1. The client must request transportation directly with CABL a minimum of 72 hours prior to the appointment date and inform the CABL promptly of any cancellation or change;
- 2. At any time, the CABL may not be able to offer the service due to the lack of availability of our accompanying volunteers;
- 3. The CABL reserves the right to cancel transportation in special situations (e.g. poor road conditions).
- 4. This service does not include transportation for urgent care (info santé 811) and last minute care.

ESTABLISH conditions and criteria for the eligibility of cultural and recreational activities and projects as follows

PARTICIPATORY BUDGET IN RECREATION AND CULTURE FOR 4 SECTORS OF ARUNDEL

Prerequisite: Presentation of the project to the Arundel Recreation and Culture Committee for recommendation to Council (which must approve them beforehand). The following types of projects, activities or events are eligible:

Must have a priority impact on the entire sector:

- a. Projects: e.g.: billboards, bulletin boards, art installations, street/intersection decorations, flowerbeds/plants, development of a meeting place, observation trails, etc.
- b. Activities or events: e.g., community dinner, corn roast, parade, community mural, artwork archival photo album of area/historical collection, beautification contest and prizes, etc.

Expenses may not include salaries or fees paid to participants.

Expenses will be reimbursed upon presentation of invoices, maximum reimbursable per sector: \$500 + taxes.
