12. RECREATION, CULTURE AND COMMUNITY LIFE

12.1 Financial Assistance Program - Day Camp - Summer 2023

WHEREAS the municipality wishes to promote the accessibility of a day camp during the summer season to all children of Arundel, and this, despite the fact that the municipality does not offer this service

WHEREAS the municipality wishes to support parents financially by reimbursing a portion of the fees for the registration of a child to a day camp

2023-01-016 THEREFORE, it is moved by councillor Tamara Rathwell and unanimously resolved by those present:

TO GRANT financial assistance to cover a portion of the fees for registration in a long term day camp (3 weeks or more) for the 2023 summer season:

- For a three (3) or four (4) week camp: a maximum of \$150 per child between the ages of 5 and 15;

- Proof that the registration is for a long term day camp (promotional leaflet, extract from the website...)

AND that refund requests must be deposited no later than September 29, 2023. No retroactive payments will be made after this date.

12.2 Renewal of the Non-Resident Expense Reimbursement Program for Certain Out of Territory Activities - 2023

WHEREAS the importance of healthy lifestyle habits and physical activity among young people aged 18 and under as well as adults

WHEREAS the difficulty of small municipalities to offer a wide range of organized sports activities, due to the lack of infrastructure and the small number of young people residing on their territory;

WHEREAS the municipality wishes to promote accessibility to sports facilities and activities for all, and this, in an equitable manner and according to the available budgets;

WHEREAS the municipality wishes to provide financial assistance for community school trips

WHEREAS the additional expenses paid by non-residents are reimbursed up to a maximum of \$300 per child under 18 years of age and \$200 per adult (18 years of age and over), for a maximum amount of \$600 per family. The right to reimbursement is non-assignable and non-transferable.

WHEREAS it has established a program to this effect as of January 18, 2022 by virtue of its resolution 2022-0013.

12.3 Renewal of the accompaniment assistance program - transportation to medical appointments for persons 65 years and older, in partnership with the Centre d'action bénévole des Laurentides (CABL)

WHEREAS the municipality wishes to respond to the particular needs of its many seniors in accordance with Orientation 3 entitled "Wellness, Health and Safety" of the Council's 2023 Major Orientations, as well as the objectives of the Municipal Family Policy 2021-2025

WHEREAS the needs of the municipality's seniors in terms of transportation, particularly for medical appointments that are often located at significant distances and that require vehicles and often a driver for both the journey to and from the appointment

WHEREAS it is appropriate to facilitate access to transportation services for its seniors by setting up an assistance program, free or at low cost, for this purpose, in partnership with the Centre d'action bénévole des Laurentides (CABL)

WHEREAS the municipality will reimburse CABL for each kilometer traveled, the reimbursement will be capped at 200 km;

WHEREAS travel beyond 200 km can be costly, the cost of transportation beyond 200 km will be shared between the municipality and the senior, both parties paying 50% of the cost;

WHEREAS the municipality wishes at the same time to encourage local volunteering with the Centre d'action bénévole des Laurentides (CABL) to make this service even more effective

WHEREAS it has established a program to this effect on April 19, 2022, by virtue of its resolution 2022-0083.

12.4 Winter Closure of Playgrounds

WHEREAS the Municipality of Arundel currently has a playground at Beaven Creek Park

WHEREAS the play areas in the parks are not designed for four-season use

WHEREAS in winter, the shock-absorbing surfaces used to cushion falls harden when they freeze and no longer play their role

WHEREAS winter clothing is a nuisance for children: cords or ties can get caught in components of play structures, causing fractures or choking

WHEREAS mittens prevent a good grip or secure holds and synthetic materials in winter clothing decrease the resistance to sliding, especially in plastic slides; they can increase the speed of the descent and make the arrival dangerous, especially if the ground is frozen

WHEREAS, snow, ice or freezing rain can make playing surfaces, handles and ladders very slippery, causing falls and fractures or other injuries;

WHEREAS the Alliance québécoise du loisir public, the Institut Québécois de la Sécurité dans les Aires de Jeu and the Institut national de santé publique du Québec recommend that playgrounds be closed in winter.

2023-01-019 THEREFORE, it is moved by councillor Stéphane Carrière and unanimously resolved by those present:

TO CLOSE access to the playground at Beaven Creek Park until April 15, 2023;

AND TO KEEP OPEN the park grounds to encourage children and families to play free play activities such as making snowmen, building structures, rolling in the snow, playing angel and even playing snow soccer.
