6.3 Adoption - By-law 289 on the Salary of Elected Municipal Officers

WHEREAS the Act respecting the salaries of elected municipal officials (R.S.Q., c. T11.001) determines the powers of the Council with respect to the determination of remuneration

WHEREAS Section 3 of the Act respecting the remuneration of elected municipal officials (R.S.Q., c. T-11.001) indicates that the remuneration of elected officials may:

- Be fixed on an annual, monthly or weekly basis;
- Be fixed on the basis of the member's presence at any meeting of the Council of another body of the Municipality, of a mandated body of the latter or of a supramunicipal body within which he or she holds the position giving him or her the right to this remuneration;
- Result from a combination of these two methods of remuneration.

WHEREAS it is necessary to amend By-law No. 192 on the salary of elected municipal officials adopted in 2014 in order to increase the salary of elected officials, to modify the terms of payment as well as the reimbursement of expenses, for greater equity of treatment and to correspond more closely to the reality of their office and the salaries of elected officials in general

WHEREAS all members of council declare having received the by-law more than seventy-two (72) hours before this meeting

WHEREAS all council members declare that they have read this by-law and waive its reading

WHEREAS a notice of motion of this by-law was duly given at the regular council meeting held on January 24, 2023

WHEREAS a public notice of this by-law was duly given on February 20, 2023

6.4 Presentation and adoption - Second draft by-law 290 amending zoning by-law number 112 concerning principal place of residence (PRS) and prohibiting them in certain zones

WHEREAS the Zoning By-law number 112 of the Municipality of the Township of Arundel is in force

WHEREAS the Municipality has the power, under the law, to amend its zoning by-law

WHEREAS a notice of motion was deposited on February 23, 2023, along with the Draft by-law

WHEREAS a public consultation meeting was held on March 2, 2023

WHEREAS the adoption procedure was regularly followed

WHEREAS following the modifications made to the provincial government's Tourist Accommodation Act, the Municipality wishes to prohibit the use of "Establishment of principal residence" on its entire territory, with the exception of zone PA-10

WHEREAS the Tourist Accommodation Act allows a municipality to prohibit, in certain zones of its territory, the use of establishment of principal residence, subject to an adapted referendum process

WHEREAS the Municipality of the Township of Arundel wishes to limit this type of use on its territory in order to reduce the risk of nuisance, to control the operation of this type of use and to maintain the supply of accommodation in the longer term

WHEREAS in accordance with section 445 of the Quebec Municipal Code, at the meeting of February 21, 2023, a notice of motion was given and the draft bylaw was deposited

WHEREAS it is appropriate to create a new use "Establishment of principal residence" (c11-1) as a use specifically prohibited everywhere, except in zone Pa-10

WHEREAS all members of council declare having received the by-law more than two (2) days before this meeting

WHEREAS all councillors declare that they have read this by-law and waive its reading

THEREFORE, it is moved by councillor Simon Laforest and resolved by the majority present:

TO ADOPT the second draft of by-law 290 amending zoning by-law number 112 concerning major tourist establishments (MTEs) and aiming to prohibit them in certain zones, a copy of which is attached as Annex "C".
