7.2 Canada Day – Acceptance of subsidy

WHEREAS the Municipality of the Township of Arundel has been awarded a grant in the amount of \$1,920 by the Department of Canadian Heritage, through the Celebrate Canada Program of the federal government, for the celebrations of July 1, 2024;

WHEREAS a grant agreement must be signed and forwarded to the Department of Canadian Heritage, in the context of the programme *Canada en fête*, conditional upon confirmation and authorization from the MAMH to enter into this agreement;

AUTHORIZE the Director General to sign the grant agreement from the Department of Canadian Heritage granted to the Municipality of the Township of Arundel, within the framework of the federal government's Celebrate Canada Program, for the celebrations of July 1, 2024, which must be forwarded to the Department of Canadian Heritage once confirmation and authorization from the MAMH to enter into this agreement has been obtained.

7.3 FQM – membership renewal

WHEREAS the *Fédération québécoise des municipalités* (FQM) defends the political and economic interests of the regions, by providing municipal organizations, on a non-profit basis, with a pool of expertise enabling them to fully meet all their current and future responsibilities;

WHEREAS that the Municipality of the Township of Arundel has been a member of the FQM for several years and wishes to renew its membership;

WHEREAS that the annual membership fee is \$1045.58 plus the defence fund of \$40.14, all before taxes;

AUTHORIZE an expense in the amount of \$1,085.72 (before taxes) in favour of the FQM as annual dues and contribution to the defence fund.

7.4 Request to revise the Act respecting municipal taxation with respect to Sûreté du Québec taxes

WHEREAS a request has been received for support from the municipalities of Upton and Blanc-Sablon, by their respective resolutions 2024.04.81 and 2024-059, and resolution 2024-06-9700 from the municipality of Cookshire-Eaton, for a review of the Act respecting municipal taxation for Sûreté du Québec taxes;

WHEREAS, under the Act respecting municipal taxation, the Government of Quebec may introduce taxes on the services of the Sûreté du Québec (hereinafter referred to as the "SQ");

WHEREAS local municipalities are required to pay 50% of the costs of SQ services, in accordance with the relevant by-law;

WHEREAS the tax burden on municipalities continues to increase;

WHEREAS local municipalities are subject to government decisions regarding SQ funding;

WHEREAS local taxpayers are under increasing fiscal pressure as a result of this high contribution;

WHEREAS the SQ tax rate is currently determined unilaterally, without consultation or consideration of the needs and financial capabilities of municipalities;

IT IS THEREFORE **PROPOSED** by Councillor Jonathan Morgan and unanimously resolved by those councillors present:

THAT a formal request be made to the Government of Québec for a review of the Act respecting municipal taxation for police services in order to reduce the tax burden imposed on municipalities for the financing of the Sûreté du Québec; and

THAT this resolution be forwarded to the following authorities: the Ministère des Affaires municipales et de l'Habitation, the Ministère du Travail, de l'Emploi et de la Solidarité sociale, the MRC des Laurentides, the Fédération québécoise des municipalités du Québec, the Union des municipalités du Québec and the Argenteuil MNA Agnès Grondin.

7.5 Hiring – First Responder

WHEREAS first-line response to medical emergencies on the territory of the municipalities of Barkmere, Huberdeau, Montcalm and Arundel is provided by the Arundel First Responders service;

WHEREAS there is a need to fill a first responder position;

WHEREAS Mrs. Audrey-Ann Robert has expressed an interest in the position of first responder;

WHEREAS the Director of First Responders, Sonia Larrivée, confirms that she meets the hiring criteria for the position of first responder and recommends her hiring;

IT IS THEREFORE **PROPOSED** by Councillor Carole Brandt and unanimously resolved by those present to :

HIRE Ms. Audrey-Ann Robert as First Responder, under the conditions currently in effect.

7.6 Modification to loan bylaw 302-2024

WHEREAS the unofficial translated wording of paragraph 4 of loan by-law 302-2024, adopted at the special assembly held on June 11, 2024, reads as follows:

"For the purpose of paying the expenses provided for in this by-law, in addition to said contribution by way of the TECQ program, Council is authorized to borrow a sum of \$527,038 over a 15-year period, and \$32,154 financed from the surplus."

WHEREAS Loan By-law 302-2024 is currently in deficit to cover the related expense, namely the repair of the roadway on chemin de la Rouge, said by-law decreeing an expense of \$1,451,900 and a loan not to exceed \$527,038, the TECQ grant not being explicitly allocated thereto.

WHEREAS article 1076 of the Municipal Code permits the amendment of a loan by-law by resolution in the present circumstances;

IT IS THEREFORE PROPOSED by Councillor Marc Poirier and unanimously resolved by those councillors present to :

REPLACE the translated wording of paragraph 4 of loan by-law 302-2024 with the following:

9.1 Acquisition of three educational radars

WHEREAS a request was made to the Ministère des Transports for permission to install educational radars on routes 327 (Route Morrison and Rue du Village) and 364 (Route Doctor Henry) as per resolution 2023-04-083;

WHEREAS the issuance of the aforementioned permission from the Ministry was granted under number 8809-23-10068;

WHEREAS the acquisition of educational radars is included in the municipality's three-year plan adopted in December 2023;

WHEREAS the municipality has obtained financial assistance from the Programme d'aide financière du fonds de la sécurité routière in the maximum amount of \$11,725;

WHEREAS the municipality has concluded a request for quotation from the firm Tacel Itée for the acquisition of three radars based on the said financial assistance in September 2023 in the amount of \$13,385 (before taxes) but that the price was only guaranteed for 30 days and that the price may have increased;

AUTHORIZE a maximum expenditure of \$20,000 (taxes included) for the purchase of three educational radars.

URBAN PLANNING AND ENVIRONMENT

10.1 SPAIP request - Lot 6215684, located on a vacant lot on chemin Twin Lake

WHEREAS a request for a site planning and architectural integration program (SPAIP) is submitted by the owner of lot 6 215 684, located on a vacant lot on Chemin Twin Lake, dated May 17, 2024;

WHEREAS this request pertains to the construction of a single-family dwelling (h1) as the main building, with a private garage and a sugar shack (agricultural use f1) attached as accessory buildings (hereinafter referred to as "the proposed building");

WHEREAS the lot on which the proposed building is located is in the forest sector, more specifically in zone FOR-7;

WHEREAS this zone and these interventions are subject to Concordance Bylaw No. 285 respecting site planning and architectural integration programs (SPAIP) for certain zones outside the village core, to ensure concordance with By-law No. 271 modifying the Master Plan (hereinafter: By-law 285 respecting SPAIP);

WHEREAS the exterior wall cladding of the proposed building is made of real wood panelling and cornices and that its color is Maibec brand *île de sable* (074) (dark brown), thus making use of noble materials, and that its roof is Westman Steel brand Melcher green (forest green) corrugated metal, which harmonizes adequately with the construction, all using sober colors and materials harmonized with the local natural forest environment, in accordance with paragraphs d) and h) of section 3. 3.3 (5) of By-law 285 on SPAIPs, informally translated and worded as follows:

Art. 3.3.3 5) Architectural integration: architectural style, size, colors, materials

d) Encourage the use of subdued colors and materials harmonized with the local natural environment for roofs and building exteriors;

h) encourage the use of noble materials for roof and wall cladding (e.g. brick, stone and wood). For roofing, metal cladding (corrugated iron) may be accepted if it blends in well with the building;

WHEREAS the proposed building is, however, of a traditional French architectural style, whereas paragraph b) of section 3.3.3 (5) of By-law 285 respecting site planning and architectural integration (SPAIP) stipulates that the Borough Council favours an architecture harmonized with the Anglo-Saxon style of traditional residential buildings, in accordance with the assessment criterion for the SPAIP request, which informally translated reads as follows;

Art. 3.3.3. 5) Architectural integration: architectural style, size, colors, materials

b) Encourage architecture in keeping with the Anglo-Saxon style of traditional residential buildings;

WHEREAS the sugar shack proposed as an accessory building is annexed to the single-family dwelling serving as the main building and to the garage itself, which does not respect the typical character and layout of such accessory buildings, which are usually detached from the dwellings serving as their use or main building, whereas paragraph c) of section 3. 3.3 (5) of By-law 285 respecting SPAIP stipulates, as an assessment criterion for SPAIP applications, that interventions subject to the by-law must respect the typical character and layout of accessory buildings, informally translated and worded as follows;

Art. 3.3.3 5) Architectural integration: architectural style, size, colors, materials

c) respect the typical character and layout of accessory buildings (barns, garages, sheds, wood sheds);

WHEREAS this request does not meet the last 2 architectural integration criteria:

WHEREAS the importance Council attaches to this, particularly with regard to harmonizing the architecture with the Anglo-Saxon style of traditional residential buildings, given the value of the existing Anglo-Saxon architectural heritage and the regional uniqueness of this cultural heritage on the territory of the MRC des Laurentides and its role in establishing identity, all in order to ensure the project's integration into the Municipality's landscape and the preservation of its attractive qualities;

WHEREAS the Planning Advisory Committee (PAC / CCU) recommends approval of this SPAIP request, subject to the modification of the proposed French architectural style to one harmonized with the Anglo-Saxon style of traditional residential buildings, in accordance with the evaluation criterion set out in paragraph b) of section 3.3.3 (5) of By-law 285 respecting SPAIPs;

WHEREAS the mayor, in accordance with section 2.2.7 of by-law 285 (SPAIP), offers the opportunity, before the municipal council renders its decision, to any interested person who wishes to be heard with respect to this request;
