# 7.2 Hiring – Director of finance

WHEREAS the position of Director of the treasury is vacant;

# 7.4 Ch. de la Rouge, phase 2 – Billing No. 1

WHEREAS the first progressive invoice from the contractor Nordmec Inc. for the repair work on Chemin de la Rouge in the amount of \$102,799.81 (before taxes)

WHEREAS the municipality has received the payment recommendation by the engineering firm responsible for the project, EMS, dated August 11, 2025;

WHEREAS a 10% retention is applicable in the amount of \$10,279.98, for a first payment, after deducting the retention, in the amount of \$92,519.83 (before taxes);

**AUTHORIZE** the payment of \$92,519.83 (before taxes) to Nordmec Inc.;

## 8. PUBLIC WORKS AND MUNICIPAL FACILITIES

## 8.1 Tolerance road – ch du Golf

WHEREAS Section 70 of the Municipal Powers Act allows any local municipality to maintain a private road open to the public by tolerance of the owner or occupant, at the request of a majority of the owners or occupants living along the road;

WHEREAS a public presentation occurred on June 5, 2025, on the results of research into the private status of Chemin du Golf, which research concluded that the road was privately owned;

WHEREAS the municipality already carries out winter snow removal and sanding on this road by way of tolerance, as it appears in resolution 2024-05-064, due to its impact on the municipality's image and local development, given that it leads to a site and activity of great heritage value for the municipality of Arundel, namely the Arundel Golf Course, which has been in existence for nearly 75 years;

WHEREAS the residents present at the presentation, representing a majority of the occupants of the road concerned, expressed their wish that the municipality maintain its support by way of tolerance during their period of reflection on the creation of a structured private organization for the management of the road;

**2025-08-139** CONSEQUENTLY, it is proposed by Councillor Danny Paré and unanimously resolved by those Councillors present to:

**PROCEED** with the maintenance of Chemin du Golf as a tolerance road in all seasons, effective immediately and until June 1, 2026, which includes the winter snow removal and sanding that it already performs and the spring sweeping and collection of winter sand, if possible;

**THAT** the cost of the additional maintenance requested for Chemin du Golf be allocated, as is already the case for its winter snow removal and sanding by the municipality, to the municipal road maintenance budget.

#### 8.2 Purchase – Winter sand

WHEREAS the Municipality wishes to purchase winter sand, including delivery, of one thousand two hundred (1,200) metric tons of screened sand for the 2025-2026 winter season and to establish the purchase and delivery costs;

**WHEREAS** a request for a private contract for an expenditure of less than \$25,000 was made to three companies on August 14, 2025, namely Les Bois Ronds, Miller & fils, and David Riddell Excavations;

WHEREAS Les Bois Ronds submitted the lowest compliant bid in response to this request for quotation;

2025-08-140 THEREFORE, it is proposed by Councillor Jonathan Morgan and resolved by a majority those Councillors present to:

ACCEPT the bid dated August 14, 2025, from Les Bois Ronds and award the contract in the amount of \$14.99 (before taxes) per metric ton, plus royalties of 70 cents per ton, for the purchase and delivery of 1,200 metric tons of screened sand for the 2025-2026 season, for a total amount of \$18,828.00 (before taxes), and authorize the purchase and delivery of subsequent amounts at the same rates as the case may be;

**THAT** the funds for this expenditure come from the budgeted account provided for this purpose.

# 8.3 Town Hall – mandate for exterior cladding

WHEREAS on July 29, 2025, the Municipality requested bids for the renovation of the town hall roof from three companies, namely Les Constructions Provost, Constructions KG Hardy, and Toiture N. Routhier (9348-7775 Québec inc)

**WHEREAS** only one bid was received, from Toiture N. Routhier, and that it was compliant;

2025-08-141 THEREFORE, it is proposed by Councillor Tamara Rathwell and unanimously resolved by those Councillors present to:

**AWARD** the contract for the repair of the City Hall exterior to Toiture N. Routhier (9348-7775 Québec inc) in accordance with their bid 5728-2025-0810 in the amount of \$54,000.00 (before taxes);

**THAT** the funds for this expenditure come from the TECQ 2024-2028 program.

## 9. PUBLIC SAFETY

## 9.1 First responder – hiring

**WHEREAS** front-line medical emergency response services in the municipalities of Arundel and Harrington are provided by the Arundel First Responders Service;

WHEREAS there is a need to fill a first responder position;

**WHEREAS** Mr. Tommy Derome has expressed interest in the first responder position;

WHEREAS the Director of the First Responders Service, Sonia Larrivée, confirms that he meets the hiring criteria for the first responder position and recommends his hiring;

2025-08-142 CONSEQUENTLY, it is proposed by Councilor Marc Poirier and unanimously resolved by the members of Council present to:

**HIRE** Mr. Tommy Derome as a first responder under the terms and conditions currently in effect.

# 9.2 Acquisition – First Responder service vehicle

**WHEREAS** the municipality has acquired a vehicle for the First Responder service, as set out in Resolution 2024-03-041;

**WHEREAS**, under the terms of this resolution, the municipality acquired the said vehicle through a lease;

WHEREAS the municipal council deems it appropriate to become the owner of the vehicle, without the need for the said lease;

**2025-08-143** CONSEQUENTLY, it is proposed by Councillor Danny Paré and resolved by a majority of those councillors present to:

**ACQUIRE** the First Responders service vehicle with a final payment to the lessor Mitsubishi HC Capital Canada;

**THAT** this acquisition, for accounting purposes, be effective as of January 1, 2025;

**AUTHORIZE** the Director General, Philip Toone, to sign all related documents to execute this acquisition;

**THAT** the funds for this acquisition come in part from working capital in the amount of \$29,600.46 amortized over seven years beginning January 1, 2026, and that the balance of \$20,556.54 come from the unassigned surplus.
